Now is the time to begin implementing measures that can save energy and money, before colder temperatures arrive. Launched in May, the Nicor Gas Energy Efficiency Program offers rebates on energy efficient natural gas home equipment, as well as ideas and tools to help you use energy wisely. Rebates for furnaces, boilers, and water heaters range from \$100-\$400 plus you may be eligible for federal tax incentives. Another positive aspect of this program is that when you purchase qualifying energy saving equipment, your home can become more environmentally friendly due to the reduction in energy consumption.

Energy Efficiency Program

How the Program Works

Simply purchase and install a qualifying product by May 31, 2011, fill out a rebate application^{*} and you will receive a rebate check in two to three weeks^{**}. The qualifying residential equipment and their associated rebates are as follows:

High Efficiency Furnace	>/=92% Annual Fuel Utilization Efficiency; ENERGY STAR rated	\$ 200
High Efficiency Furnace	>/=95% Annual Fuel Utilization Efficiency; ENERGY STAR rated	\$ 250
High Efficiency Boiler	>/=90% Annual Fuel Utilization Efficiency; ENERGY STAR rated	\$ 350
High Efficiency Boiler	>/=95% Annual Fuel Utilization Efficiency; ENERGY STAR rated	\$ 400

Rebates for natural gas equipment purchases and energy efficiency measures are also available for business customers. *Applications must be postmarked no later than 60 days after the purchase, or by June 30, 2011, whichever comes first. **Program funding is limited and may be exhausted prior to May 31, 2011.

Need help paying your gas bill? Financial assistance is available.

Making ends meet with your family's budget can sometimes be difficult, especially if you are on a fixed income. The good news is that you may qualify for financial assistance that will help ease your burden. The Low Income Home Energy Assistance Program (LIHEAP), administered by the Illinois Department of Commerce and Economic Opportunity, helps eligible low-income households pay for energy services. Qualifying households receive monetary relief once per year to be used for energy bills. Eligibility is based on several factors including household size, location and income. Please note that LIHEAP funds are limited. The disabled and those over 60 years of age can apply now. Enrollment for the general public begins November 2. If you don't meet the LIHEAP eligibility requirements, you may qualify for Nicor Gas Sharing Program assistance. The program provides one-time annual grants of up to \$450



to qualified residential customers to help them pay their gas bill. Administered by the Salvation Army, the Sharing Program is funded by direct contributions from Nicor Gas' customers and employees. Nicor Gas also contributes \$175,000 to the program annually. For more information or to apply, visit nicor.com/financialassistance.
